


- XV Session of RA VI in Brussels

 - Task Teams (TT)





Establishment of the new RA VI structure




- The first RA VI Management Group meeting has established (23 September 2009)










- Chairs, co-chairs are appointing

- In addition, other PRs or experts could be invited to participate in MG meetings or meetings of subsidiary bodies as necessary






 New structure signifficantly differs from the previous one, with

✓ reduced number of WGs


 more flexibility in addressing specific tasks by establishing of Task Teams



Old structure


New structure






- Letter by President to the chairs of the WGs requesting recommendations for the core membership
- WMO Secretariat provides the list of nominated specialists delegated by the PRs
 - Already around 100 nominations
 The list is still open
 - ✓ If the list appears insufficient, second call for nominations will be sent to the PRs
- The WG chairs are in the process to submit to the President the first draft of the work programmes of their WGs by the common template in order to achieve consistency of the work programmes





- By the end of December 2009, the WG chairs are preparing proposals for
 - ✓ the core membership
 - establishment of Task Teams (TT) to work on specific items and deliverables TTs will have manageable number with approved composition
 - general outlines of the work plans for WGs for the period 2010 – 2013 based on
 - o approved TORs
 - the general guidance provided by the XV RA VI
 Session in accordance with RA VI Strategic Plan
 - The proposals will be reviewed and adopted by the second MG meeting in February 2010






- There is need for strengthening the cooperation and collaboration between the RA VI and the CBS Commission
 - *by involving members of the CBS subsidiary bodies to serve also as experts on relevant RAVI WGs and Task Teams*
- Secretariat is forseen to provide optimal support RA VI MG and its subsidiary bodies (WGs, TTs) up to the available WMO budget




Some basic issues



- Management Group is facing with preparation off the new WMO Strategic Plan (2012-2015)
- First complete draft of the new SP is expected to be available by the end October 2010 taking into account
 - inputs from RA VI Members outlining regional challenges and priorities
 - ✓ inputs from other Regional Associations
- For the next intersession period MG should
 - ✓ensure outcomes of the WCC-3 in the work programme
 - ✓ participate in preparation of the WIS/WIGOS implementation plan for approval by the next WMO Congress
